

Consent for eligibility on RedCap

The Wall Lab at Stanford University is studying the use of a novel combined software-hardware solution built on top of Google Glass. We hope to learn about this device's efficacy in helping children with Autism Spectrum Disorder (ASD) learn social cues, which may aid treatment in behavioral therapies.

The purpose of this screening questionnaire is to see if you meet the criteria for taking part in our research study. We will be collecting data on your family and your child. Another purpose is to see if you want to hear about other research studies that will be done in the future; we will keep the data you provide in this questionnaire confidential and de-identified. We may use these data for future research purposes done by the Wall Lab.

The questionnaire will take you about 10-15 minutes to fill out. You will not be paid for answering these questions and there is no cost to you. You may choose to stop answering the questions at any time. The risk of taking part in this interview is very small. The screening questionnaire is not designed to ask you for sensitive personal information, but it is possible that some people may feel uncomfortable answering these questions. If you qualify to take part in the study and are interested in taking part in it or in future research studies, then I will add your data to a database of interested participants. There is a small risk that people outside of the research team could learn this information, however we have taken all security and privacy measure to ensure this does not happen.

There are no benefits to you to taking part in this screening interview. However, it is possible that the information from the study that we will be doing may help other researchers in the field of developmental delays. The benefit to you of being in our database is that you will hear about studies in the future in which you may be interested. You will not be paid for answering questions in this interview since it is only to see whether you qualify to take part in the study, and whether you want to be part of a database of people who are contacted about future studies.

In addition to the questionnaires, you will be asked to submit a 3-5 minute home video of your child using Stanford's encrypted and secure email platform: MedSecureSend. The video must include 3-5 minutes of social interaction with your child (playtime and conversational components required). The Wall Lab research team will analyze the video as a complimentary data point for eligibility based on the child's phenotype. The research team will follow up with participants to submit this home video.

If you have read this form and have decided to participate in this project, please understand your participation is voluntary and you have the right to withdraw your consent or discontinue participation at any time without penalty or loss of benefits to which you are otherwise entitled. The results of this research study may be presented at scientific or professional meetings or published in scientific journals. However, your identity will not be disclosed.
